National Constitutional Convention



On 13 - 15 May the key players in Constitutional Review Process, Ministry of Constitutional Affairs, the Parliamentary Joint Oversight Committee and the Independent Constitutional Review and Implementation Commission managed to convene the National Constitutional Convention (NCC), a historic three-day gathering that took place in Mogadishu and brought together over 350 representatives from federal government, federal member states,

civil society, partners, youth and Somali diaspora with support from the UN and Norway. First in its kind since the adoption of the Federal Provisional Constitution in 2012, the NCC provided an opportunity to deepen and broaden ownership of the review process, to build consensus around strategies and timelines and to kick-off a national dialogue on outstanding constitutional priorities that need to be addressed before the end of 2019, to enable progress in other interlinked peace- and

state-building processes, such as universal elections and the implementation of the security transition plan. Participants at the convention discussed the next steps of the review process and examined issues such as the sharing of powers and resources between the federal government and the Federal Member States. The three-day national convention is the beginning of a process to give Somalia a new constitution to replace the 2012 Provisional Constitution which was agreed upon by 825 delegates at the National Constituent Assembly.

Prime Minister Hassan Ali Khaire, who led the nation in launching the process, pledged financial and political support to the process to ensure the country gets a new Constitution by the end of next year.

Mr. Khaire said there was need to finalize the constitutional process to unify the country, promote economic growth and above all deliver a new document for prosperity.

"I hereby confirm that my government has pledged \$3million for the constitution process to be finalized. However, this pledge should produce a Somalia-owned document, Somali thinking, Somali economy, Somali advice and new Somali unity that rebuilds the Somali nation we lost," Prime Minister added.

Somalia is currently governed by a Provisional Constitution, adopted on August 1, 2012, after years of conflict. The federal and state governments plan to have a new document ready ahead of the one-person one-vote elections scheduled for 2020.

Mr. Khaire said Somalia needs a new Constitution to accomplish the movement towards one-person one-vote to give the population an opportunity to pick leaders of their choice.



The Declaration of the Convention

The National Convention on the Launch of the Constitutional Review was attended by various parties representing the Parliament of the Federal Republic of Somalia, the Government of the Federal Republic of Somalia, the Judiciary, the National Independent Electoral Commission, the Boundaries and Federation Commission, the Federal Member States of Somalia, Banadir Regional Administration, Youth [groups], Women, Civil Society Organizations, Professional Associations, Religious Scholars, Somali Diaspora, People with Special Needs, Traditional Elders and members of the International Community as they met at the Royal Palace Hotel in Mogadishu, Somalia on 13th 15th May 2018.

- Being cognizant of the importance to find a solution to the existing problems in our country;
- Sincerely agreeing upon the final timeline for the completion of Constitution in a way that is free from individual and group interests;
- The Convention being committed to achieve Constitutionbased stability and lasting peace;
- Considering the aspiration and impression of all our people;
- Commending the positive impression and the integrity among the participants of this meeting as that has led to unanimity;
- Believing that the good faith which led to the previously reached agreements could be the basis for realizing further agreements during the process of the Constitutional Review Process.

The Convention focused on the discourse regarding the below mentioned issues:

- The general guiding principles of the review of the Constitution.
- 2. The procedures for a political agreement relating to the review of the Constitution.
- The procedures for the Civic Education, Awareness-raising, Public Consultations and the promotion of inclusive participation.
- 4. Development of effective and joint structures.
- 5. The kind of federalism appropriate for Somalia.
- 6. Potential challenges during the Constitutional Review Process and the way forward.

Commending the considerate leadership of the Ministry of Constitution Affairs, the Oversight Committee and the Independent Review and Implementation Commission; are committed to focus on the following priority issues:

a) During the 2018 Time Period:

- Rectifying all constitutional technical errors;
- II. The Articles in the Provisional Constitution that need to be reviewed, in form of amendment, addition and omission;
- III. An agreement must be reached between the Federal Government and the Federal Member States on the Articles that require a political negotiation;
- IV. The agreements reached by the Federal Government and the Federal Member States shall be transformed to Constitutional articles; and
- b) **During the Parliamentary Sessions of 2019,** all Chapters of the Provisional Constitution including the articles that require political negotiations must be adopted.

The National Convention calls for the following principles to serve as the basis for the Review of the Constitution:

- Ownership of the Constitution: The Constitutional Review Process must be Somali-owned and Somali-led.
- **2. Timeline:** The Constitutional Review Process must be finalized latest by December 2019.
- **3. Way forward:** The Process shall be built upon the reports prepared by the 9th Parliament, and the three options.
- **4. Inclusivity:** It is necessary for the Constitutional Review Process to be participated by all stakeholders at Federal, State, Banadir Region and Civil Society levels.
- Transparency and Accountability: The Constitutional Review Process must be one which is based transparency and accountability.

Therefore, and after all these, we have agreed:

- To be careful about delays to the Review of the Constitution;
- That the Review of the Constitution to be Somali-owned and Somali-led.
- That the finalization of the Constitution must not be dominated by only a limited number of politicians, but instead, it shall be widely participated by all Somalis.
